Private security companies contract with businesses and individuals to monitor and protect customers' property. States require a licence for private security companies employing unarmed and armed guards. Armed security guards must meet the state licence requirements for the transport of a weapon, which includes training and registration. Unarmed security guards must also meet the requirements of a state licence for training. The private security company must obtain a state license and ensure that all employees meet the state requirements. Private security companies must approach the state and provide information for every partner in the business. States may require each partner of a private security company to disclose its name, address and background information for the licence. The state may require a partner in a private security company as a qualifying agent. The qualifying agent may be required to have training and experience for the company to receive a license. For example, the qualifying agent in the state of Washington must have three years of experience as a manager or supervisor in a private security company to act as a qualifying agent. Washington also requires that the qualifying agent pass an exam to meet licensing requirements. States may also require an individual or partner in a private security company to undergo a background check to obtain a state license. For example, Georgia requires that applicants for a private security company license have no convictions involving the use of a weapon. Georgia also checks the background of an applicant for fraud and dishonesty crimes. Private security companies must have liability insurance or a bond to protect individual and corporate clients from the financial loss that is the result of the security company's action. Georgia's private security companies must have a secure link for \$25,000 from a licensed Georgian security company. The obligation is borne by any person harmed by the actions of the private security company. States may require private security companies to meet renewal requirements in order to continue operating in the state. Three most common security levels, which vary according to the sensitivity of classified information, are reserved, secrets and top secret. Due to particular concerns of sensitivity and security surrounding different types of classified information, candidates for certain federal positions must meet the requirements necessary for citizenship, background, employment and need to know to be granted security authorization. The classified information provided within federal agencies can produce serious consequences if exposed to conflict entities. To reduce the likelihood of unauthorized exposure, federal agencies require all candidates for security permissions to hold US citizenship. You will need to present proof of your citizenship, such as your passport of the United States or your birth or naturalization certificate at the time of your authorization request. If you are in the naturalization process, you must wait until the process is complete before applying. You must be employed or sponsored by a federal entity to obtain a security authorization. Only the federal government is allowed to issue security clearances. Liquidations may not be obtained or paid individually or privately. Once hired by a federal agency, your recruitment authority will guide you through the security clearance process and pay costs. You will have to successfully pass an investigation across the field according to the type of authorization your federal position requires. For example, for a reserved clearance, it will be required only to indicate five years of personal history; but for a secret superior clearance, you need to provide information dating back to your 18th birthday. You will have to complete the National Security Questionnaire (SF-86) completely and accurately. Periods of investigation often vary, depending on length, depth, scope and accuracy of the information provided. A federal investigation agency will then carry out checks on your credit, criminal record, work history, foreign activities and personal references. Some permissions also require a polygraph exam. This is the most common with top secret clearance investigations. To obtain the appropriate security authorization for your federal work, your agency must verify that you have a certain level of need to know to access certain classified information. As the classified information is safer when managed by poorer people or entities, the requirements and duties inherent in your position should be able to justify your need to access classified information. If, for example, you're a special agent and so you have access highly classified computer databases and human source information to do your job properly, you need to know required for maximum secret clearance.
